READ CAREFULLY - THIS AFFECTS YOUR LEGAL RIGHTS

In exchange for participation in the activity of Classes organized by Springfield Dance ("Studio"), of 5531 International Parkway, Springfield, Illinois, 62711 and/or use of the property, facilities and services of Studio, I agree for myself and (if applicable) for the members of my family, to the following:

1. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by Studio, or the employees, representatives or agents of Studio.
2. I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge Studio for injury, loss or damage arising out of my or my family's use of or presence upon the facilities of Studio, whether caused by the fault of myself, my family, Studio or other third parties.
3. I agree to indemnify and defend Studio against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of or presence upon the facilities of Studio.

Acceptance of Studio Payment Policy

- Payments are due the first lesson of the month.
- A **\$5 late fee will be charged if tuition is not received by the 10th of the month.** *unless prior notification is given to drop a class.*
- **THERE WILL BE NO REFUNDS ONCE TUITION HAS BEEN PAID AND NO CREDITS FOR MISSED CLASSES.**
- All drops and class changes must be made in writing by filling out an add/drop form at the studio. (Please do not give notification to the teacher, as our instructors are not responsible for doing any of the billing)
- All drops/changes **MUST** be made before the first of the month, or you are responsible for paying for that month.
- Make-up lessons may be arranged by enrolling in a make-up class online.
- A \$20 fee will be charged for returned checks
- **ONCE RECITAL FEES HAVE BEEN PAID, THERE WILL BE NO REFUNDS.**
- Make checks payable to Springfield Dance
- If you pay for the entire year by cash or check before classes begin, you will also receive a \$20 discount.
